Subject: Regarding my continuous fast in furtherance of Swami Gyan Swaroop Sanand Ji's (after this referred as 'Swami Sanand') cause regarding protection & preservation of Divine Mother Ganga Ji and your unprecedented anti-Ganga mentalities is leaving before me no option but to follow the path of Supreme Sacrifice by leaving even oral water intake from 27-04-2019; if demands are not fulfilled by 25th April, 2019.

Sir,

1- Matri Sadan is a divine organization, which fights against corruption and preserves the environment. You are well aware of that in furtherance of the Ganga related demands of Swami Gyan Swaroop Sanand Ji, which are to:-

- i- Cancel all existing and proposed dams on Ganga Ji and her tributaries rivers (Bhagirathi, Alaknanda, Mandakini, Pinder, Dhaul Ganga, Nandakini) with immediate effects.
- ii- prohibit mining & forest cutting in highest flood plain area of Ganga Ji (especially in Kumbh City Haridwar).
- iii- Constitute an autonomous Ganga Bhakt Council to take decision in the interest of only Ganga Ji.
- iv- Enact the Ganga Act for conservation of Ganga Ji,

I initiated my Tapasya/continuous fast in the same form and same manner as Swami Sanand Ji on 24-10-2018, today is the 178th days of Tapasya. It is not a hidden fact that on his 111th day of Tapasya Swami Sanand Ji was forcefully kidnapped from the

Matri Sadan to get assassinated in AIIMS Rishikesh on the very next day i.e. 11th Oct, 2018. Taking the lead in society for this great selfless endeavour Saint Gopaldas Ji came forward but he too was made disappeared from the AIIMS New Delhi on 04th Dec, 2018, and at present we I don't know whether he is even alive or not?

- 2-In the meantime on 29th Nov, 2018 I was too forcefully kidnapped by the stupid and pro-mafia Sh. Manish Kumar,SDM, Haridwar and got admitted in the same Hopital i.e. AIIMS Rishikesh, wherein I had been administered lethal poison and had I not filed LAMA to leave AIIMS Rishikesh on 01 Dec, 2018 I too would have been lost my life as Swami Sanand Ji. One of the key reason of getting me murdered by current most corrupt district magistare Haridwar Shri Deepak Rawat is that once he attempted to murder me on mere legitimate & genuine and peaceful dissent shown by me in the meeting arranged by Shri Deepak Rawat to get him honoured from a group of pro-mafia supported organization on the name of Pandit Madan Mohan Malviya Ji, getting no action taken by the police a complaint case was filed before the competent court and the same is pending and I am the key witness/evidence, which can send him behind bar for his heinous crime.
- 3-Shri Deepak Rawat is so pro-mafia mentality that the report prepared by the IISWC Dehradun for Uttarakhand Forest Development Corporation and it had to be submitted before the MoEF & CC and MoEF & CC and the NGT had to decide further action based on that report, which on 26-02-2018 the NGT totally rejected but before that relying on that report which even a copy was not forwarded to DM Haridwar, Shri Deepak Rawat, district magistrate Haridwar took 30 crores rupees from the mining mafia to start totally illegal & destructive mining in Ganga Ji , whereas other side he even did not comply with the direct binding directions given to him by the CPCB and the NMCG to close down mining & crushing in Ganga belt.
- 4-As far as present Uttarakhand Govt. lead by Shri Trivendra Singh Rawat is concerned he is directly connected with mafia. This is the reason neither he himself nor he deputed any diligent officer ever to come to do dialogue till this date. He has posted most corrupt and incompetent Shri Deepark Rawat as the DM of Haridwar only to get collected money from the mining & crushing mafia. The mafia connection of Shri Trivendra Singh Rawat lead Government is unprecedented.

- 5-A group of social organizations arranged a March on 9th March 2019 from New Delhi to Haridwar in support of my ongoing Tapasya and they had to reach Matri Sadan on 17th Marh, 2019 before staying at several places in the nights. On the night 16th March, 2019 they have to stay at Jwalapur where the members of their group were arranged for the night stay and dinner but Shri Deepak Rawat himself and also from the Intelligence agencies threatened local members as much as of facing dire consequences for their support to members of March that they were afraid a lot and even did not arrange for the food to Marching groups.
- 6-Another Grave situation came to the fore is that STPs are using bleaching powder in Ganga Ji to diminish the degree of choliforms and resultant is killing of fishes in Ganga Ji.
- 7-Another great downfall in your tenure came to the fore is that in Haridwar the ear of country, which previously used to work independently and report truly is now fabricating the facts sitting together with Local Intelligence Unit and Special Branch, both comes under State Govt. One officer of IB Smt. Nupur has not only sent the PMO false information but she is also engaged in misinformation about our purest divine organization on this earth "**Matri Sadan**". Situation became bad to worse when we wrote the same to the PMO still no action has been taken till this date. So it can easily be guessed the stage our country has to pass over.
- 8-You neither replied any of the letters of Swami Sanand Ji nor have replied any of the letters of mine till this date, whereas all offices of New Delhi state that only you can take decision to scrap under construction dam based hydro power projects on the National River Ganga Ji and its tributaries. It is also being said that all these projects are being constructed on your direction. **Since Sanand had written you first letter on 24th Feb, 2018 and sent reminder before initiating his fast on 22nd June 2018, therefore, if it is said that since so much percentage works have been finished and now it cannot be scrapped it will be an open & grave insult of Anshan/continuous fast/Satyagraha/Tapasaya.**
- 9-At present works on under construction dams are being done very quickly; especially on Singoli-Bhadwadi power project, which is being said of one of the persons having

direct connection with the Govt. of India and it is his pressure that even Swami Sanand Ji's & my Tapasya is unheard till this date.

10- Constructing Ghats, STPs, Mortuary, etc. from the 20 thousand crore rupee of Namami Gange fund is making the problem for Ganga Ji never lasting because onus of doing all these works lie on the local civic bodies, whereas allotments from Central Fund has opened a new form of corruption in thousand of crores. All these activities are being done only to manage the fund of Namami Gange, whereas the factors which give Ganga Ji her Pristine status are being destroyed by doing mining, constructions of hydro power projects, etc.

11- In this serious situation:-

- i- Where Swami Sanand Ji like great scientist having served as DEAN of IIT Kanpur besides HoD of the same and also founder Member Secretary of the CPCB and whose dedicated works brings Pride for Berkeley University, California, U.S.A couldn't get heard by you,
- ii- The CPCB order of stopping mining & crushing in Ganga Ji and surrounding areas to some extent in Haridwar is withdrawn without any information to us during my ongoing fast and when we requested the CPCB to hear us no action is being taken on our request because the mining & crushing mafia gave crores of rupees to the concerned officer of CPCB sitting on responsible post,
- iii- District Magistrate Haridwar Shri Deepak Rawat attempted to murder Matri Sadan's saints and Matri Sadan's complaints to the Government of Uttarakhand did not get any notice while Shri Deepak Rawat keeps a group of journalists to spread his false fame from the money gets from more than 100 stone crushers being operated in the Ganga belt which are engaged in doing heavy illegal mining against which complaints are made to the CPCB and the CPCB sent those complaints for action to the same Deepak Rawat,
- iv- Each & everyday 100 stone crushers are doing illegal mining, which are being complained to the local administration but no action is being taken at all because

the illegal money accrued by the mining & crushing mafia is being distributed from top to bottom in administration and political leaders,

- v- Corruption is so rampant that the Home Secretary orders the Police to not to interfere in mining matters directly and without being asked for the same by the Revenue official/s, who are themselves promoting illegal mining,
- vi- voices of the people living in dam affected areas are either got bought or if not so they are implicated in false cases to get harassed,
- vii- No person from the Central Government nor Chief Secretary of Uttarakhand Shri Utpal Kumar Singh himself come to do dialogue or gave time for meeting,
- viii- Corruption is spreading so quickly that Ganga Ji is being destroyed, the Principal Secretary Shri Nripendra Mishra Ji, who, though clamped a photo of Father of the Nation Mahatma Gandhi above his head on the wall of the room due to the compulsory national custom, but he too keeps opposite thinking about Mahatma Gandhi, Satyagraha/Tapasaya/continuous fast & Matri Sadan.
- ix- Judges and magistrates of the lower judiciary of Haridwar while hearing the genuine & legitimate cases of Matri Sadan either dismiss the same or keep it pending and while doing so they even did not follow the law decided by the reported orders of Hon'ble Supreme Court and the Hon'ble High Court, Nainital, the law decided by the Hon'ble Supreme Court on 03-11-1981 in the matter of Gulam Abbas & Ors vs State of U.P. & Ors and reported in 1981 AIR 2198, 1982 SCR (1)1077 that Section 144 Cr PC cannot be imposed on private land still corrupt district magistrate imposed section 144 Cr PC on Matri Sadan resident campus and Revision Petition filed against the same before the District Court Haridwar was dismissed ignoring the Hon'ble Supreme Court above mentioned order,
- x- Even the demands which were accepted by the Union of India before assassination of Swami Sanand Ji have not been implemented till this date

So in this gloomy situation where my Tapasya is being ignored and I am not seeing any way of getting heard I too decided to follow Swami Sanand Ji and his

dedication for Ganga Ji and therefore I too have decided to leave even taking oral intake of water.

Therefore, with my healthy mind, sub-conscious mind, intellect and from the core of my pure inner heart I have decided that if my demands, which are nothing but what Swami Sanand Ji's were, are not fulfilled till 25th April, 2019 I would leave even taking oral water intake from 27th April 2019.


