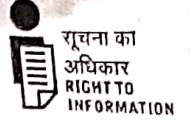

Minutes of Meeting of Committee to oversee the process and other works related to installation of the statue of Swami Vivekanand and development of surrounding area/ ambience held 26.11.2018 at 11:00 AM in Room No. 141, Engineering Department, Administration Building, JNU. Following were present:-

In the beginning the Chairperson welcomed the members present in the meeting.


The matter of installation of Swami Vivekanand statue and Development of surrounding area/ambience was discussed in detail. The conceptual drawings pertaining to the work under reference provided by M/s Kriti Consultants were placed before the committee and the following was agreed upon after due deliberations-


1. Ramps, Tectile Tiles, SS railings etc. for Differently abled users be necessarily provided wherever required.
2. The committee also recommended to provide concrete benches at corners of circulation area/passage around the statue with proper lighting, horticulture work etc..
3. The committee desired that samples of Granite stone slabs and CC paver blocks may be got approved from the competent authority before execution.
4. After having visited the site, the committee suggested to remove minimum two defunct/disused bays of Temporary MS framed structure meant for supporting creepers existing in the close vicinity of the platform in order to enhance visibility and ambience of the surrounding area. The committee also opined that some planters having seating arrangement may also be constructed as per site constraints.



5. The committee was of the view that the circulation area/ passage should be properly lit with Bollard lights etc.
  6. It was also desired by the committee that detailed estimates for Civil, Electrical and Horticulture works be prepared immediately as the work is of emergent nature.


It was also decided that next review meeting will be held in the 1st week of December' 2018, however specific date and time will be communicated in due course.
